

GENERAL TERMS AND CONDITIONS

I. PREAMBLE

These General Terms and Conditions (hereinafter: **GTC**) contains the rights and obligations of the "The Rock" Museum Public Benefit Foundation (1014 Budapest, Lovas út 4 / C, 18728488-2-41, 01-01-0012135) as the domain owner and oparetor of the https://aszikla.hu and of a natural or legal person, or an organization without legal personality, who uses the services and donation opportunities of the website.

II. PARTIES

II.2. SUPPORTER

The natural person, legal entity or an organization without legal personality, who uses the services and donation opportunities available under the domain indicated in the preamble.

Foundation and Supporter are hereinafter jointly referred to as the Parties.

III. PURPOSE OF THE FOUNDATION

The mission of the Foundation is to show that it is possible to act like a human being in a dictatorship and during a wartime period, to choose the good. True heroes are the ones who heal and help, not take someone else's life. It also aims to present the true face of war and to convey authentic history to the general public for educational purposes. The Foundation's activities promote research and understanding of social, cultural and scientific contexts and encourage continuous education.

The property of the Hospital in the Rock as a building and institution bears a historical and scientific monument of outstanding importance for the past of Hungary. The Foundation operates a museum presenting the history and technology of the facility, military medicine, disaster and civil protection. It collects, preserves and protects cultural goods in the context of activities of public interest.

In the course of this activity, the Foundation performs public tasks in accordance with Section 3/A(1) of Act CXCV of 2011 on Public Finances (Áht.).

IV. PURPOSE OF DONATION COLLECTION

The Foundation is a committed supporter of the maintenance and transmission of Hungarian culture and the transmission of real values.

It uses the donations for the following purposes:



- To maintain the Hospital in the Rock Nuclear Bunker Museum and to convey the value of peace
- To support class trips for disadvantaged children
- Collection expansion, collection and restoration of exhibition objects
- Scientific work, to research the history of the Hospital in the Rock
- To acknowledge and reward the work of people who play a significant role in the history and research of the Hospital in the Rock
- Educational activities and to share the collected research results with the general public.

In case of offering a specific donation, we offer a museum visit as a non-consideration service according to 350/2011. (XII. 30.) Gov. Decree on certain aspects of the management of civil society organizations, fundraising and public benefit, pursuant to § 1 (5) a), b), § 4 (1) e), § 6.

V.5. DONATION THROUGH THE DONATION MACHINES OF THE FOUNDATION

It is also possible to support the work of the Foundation by using our donation machines in the Hospital in the Rock Museum. The donation machines only accept credit cards.



VI. DONATION CERTIFICATE

The Ectv. (Act CLXXV of 2011, § 2, paragraph 20) may, in accordance with the general rules of corporate tax, apply tax relief on the benefit of the amount of money (donation) allocated to the "The Rock" Museum Public Benefit Foundation in the tax year, provided that the organization donates to support a public benefit activity and has a certificate issued by the non-profit organization for the purpose of establishing the tax base. Under the tax relief, the donor does not have to increase his pre-tax profit by the amount of the donation and can reduce his pre-tax profit by 20 percent of the value of the donation.

At the request of the supporter, the Foundation issues a certificate suitable for the use of the tax credit.

VII. ESTABLISHMENT AND SCOPE OF THE CONTRACT

The Supporter accepts the GTC by providing donation by online payment, bank transfer, on the spot cash and/or credit card payments to the Foundation. The donation contract is concluded between the Supporter and the Foundation with the provision of the donation and the acceptance of the GTC.

A new donation between the same Parties as above shall be deemed to constitute a new individual contract. The contract is not a written contract. The language of the contract is Hungarian. The contract is for a definite period.

VIII. THE TERMINATION OF THE CONTRACT

VIII.1. THE TERMINATION OF THE CONTRACT

The contract is terminated upon its fulfillment (the transfer of the donation).

VIII.2. THE ABOLITION OF THE CONTRACT

The contract may be terminated by mutual agreement of the Parties or:

- by the Foundation if the donation is in breach of good morals or by law bypassed;
- on the part of the Supporter, if there are circumstances justifying the nullity or challenge of the contract, or if there is a material change in its circumstances within 14 days after the donation is granted, which would justify the recovery of the donation.

In case of termination and repayment to the Supporter, the Foundation shall not pay interest, the costs of the transfer shall be borne by the Supporter, unless the dissolution is due to the Foundations conduct.

IX. MISCELLANEOUS PROVISIONS

In matters not regulated in the individual contract between the parties, these GTC shall prevail.

Matters not regulated in the GTC shall be governed by Hungarian law, primarily the Civil Code and the Hungarian legislation in force at any time. In the event of a dispute, the Hungarian court with jurisdiction and jurisdiction under the general rules shall act in the matter.
